# Privacy Policy & Personal Information Collection Statement

#### **Privacy Commitment**

BMW Financial Services Hong Kong Ltd. ("Company"), and BMW AG, (collectively called the "BMW Group" and "We"). Your privacy is our priority. We respect the privacy of our customers' personal information. will, at all times, comply with the Personal Data (Privacy) Ordinance ("Ordinance"). Our commitment is premised on the following principles:

a. We collect only necessary personal data from customers for the provision and marketing of services and products.

b. Personal data will only be used for the purposes specified and not for other purposes except with the consent of our customers.

- - All practicable steps will be taken to ensure customers' personal data are kept securely, confidentially and accurately. Such data will not be retained longer than it is necessary. Only authorised personnel can access or process the personal data of customers.
- Customers have the right to access or correct their personal data.

### Notice to Customers and Other Individuals relating to the Personal Data (Privacy) Ordinance
